

ORDINANCE NO. 2411

**AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
AMENDING SECTION 10.28.230 OF THE
MERCED MUNICIPAL CODE DEALING WITH
NO PARKING ZONE (COOPER AVENUE)**

**THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Section 10.28.230 of the Merced Municipal Code dealing with no parking zones is hereby amended by adding the following portion of the following streets:

<u>“Street</u>	<u>Portion</u>
North side of Cooper Avenue	Beginning at the southwest corner of 2525 Cooper Avenue beginning at the western return of the driveway entrance, then westerly 40 feet
North side of Cooper Avenue	Beginning at the southeast corner of 2525 Cooper Avenue beginning at the eastern return of the driveway entrance, then easterly 40 feet”

SECTION 2. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 3. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 4. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.

The foregoing Ordinance was introduced at a regular meeting of the City Council of the City of Merced on the 15th day of July 2013, and was passed and adopted at a regular meeting of said City Council held on the 5th day of August 2013, by the following called vote:





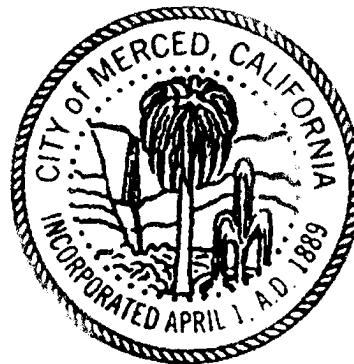
