## Citizen's Police Academy

### Enrollment Application and Program Information

#### **Program Description**

The Merced Police Department Citizen's Police Academy is an 11-week program that consists of one three hour session per week. The program is intended to:

- Give citizens an overview of their police department's functions and operating procedures
- Expose the participant to some of the training required of officers
- Develop a partnership with citizens and obtain valuable feedback regarding making our community safer

#### **Participation**

Potential candidates for the Citizen's Police Academy must meet the following criteria:

- Be at least 18 years of age
- Live or work in the City of Merced
- No felony convictions
- No misdemeanors within one year of application
- Attend at least 80% of academy classes
- Participation is limited to twenty-five students per academy class

#### **Selection Process**

Citizen's Police Academy participants are selected by the Chief of Police through an application process

- Upon receipt, applications are screened for completion of all requested information
- A modified background check is completed on each applicant
- Program Coordinator will provide input to the Chief of Police, who will make the final selection
- Any requirement may be waived or modified upon review and approval by the Chief of Police
