## **RULES AND REGULATIONS**

- 1. The purpose of the block party is to promote neighborhood involvement for the mutual protection and harmony of the area.
- 2. The intended location and area can be closed off, if necessary, without serious disruption of traffic or public safety.
- 3. The block party will last no longer than four hours and will end no later than 10:00 pm.
  - 4. Not more than 50 percent of the intended participants reside outside of the immediate area of the block party.
- 5. Permission has not been issued within the preceding three months allowing ta block party in the same general location and area.
- 6. The intended location and area is not in such close proximity to hospitals, churches or businesses as would likely result in the disturbance of these entities
- 7. No commercial activities are being planned in connection with the block party.
- **8.** Fifty percent of the residents in the area are to be included in the block party and have agreed to have the block party. The sponsor of the block party will be required to submit in writing to the Police Department a written form signed by all persons living within the boundaries of the block party agreeing to the party.
