1. **APPROVAL OF AGENDA**

3. **COMMUNICATIONS**

4.2 **Building Department Update**

Assistant Chief Building Official STEPHENSON gave a brief update on the Building Department activities; including, changes in staffing levels, Master Plan policy change, projects completed in 2013, and anticipated projects for 2014. Mr. STEPHENSON also answered questions posed by the board members.

4.3 **Code Enforcement Update**

Code Enforcement Officer MEDINA gave a brief update on Code Enforcement activities; including, a decrease in staffing levels to only one Code Enforcement Officer in 2014, as well as an increase in the number of Code Enforcement cases from 2012 to 2013, and answered questions from the board members.

Housing Program Specialist HAMILTON gave a brief update on the CalHome 12 grant program, and answered questions from the board members.

Assistant Chief Building Official STEPHENSON replied that the City is still contracted with a CASp (Certified Access Specialist) to perform CASp functions, and that an Annual ADA Report is prepared by the City's Architect describing the City's continued efforts for ADA Compliance.
