

ORDINANCE NO. 2430

**AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
AMENDING SECTION 10.28.230 OF THE
MERCED MUNICIPAL CODE DEALING WITH
NO PARKING ZONE (BUENA VISTA DRIVE)**

**THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Section 10.28.230 of the Merced Municipal Code dealing with no parking zones is hereby amended by adding the following portion of the following streets:

| <u>“Street</u> | <u>Portion</u> |
|---------------------------------|-----------------------------------------------------------------------------------------------------|
| South side of Buena Vista Drive | Beginning at the southeast corner of North Highway 59, thence easterly 15 feet |
| South side of Buena Vista Drive | Beginning at western return of the west driveway at 3360 North Highway 59, thence westerly 25 feet |
| South side of Buena Vista Drive | Entire length between both driveways at 3360 North Highway 59 |
| South side of Buena Vista Drive | Beginning at eastern return of the east driveway at 3360 North Highway 59, thence easterly 25 feet” |

SECTION 2. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 3. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be

invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 4. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.






