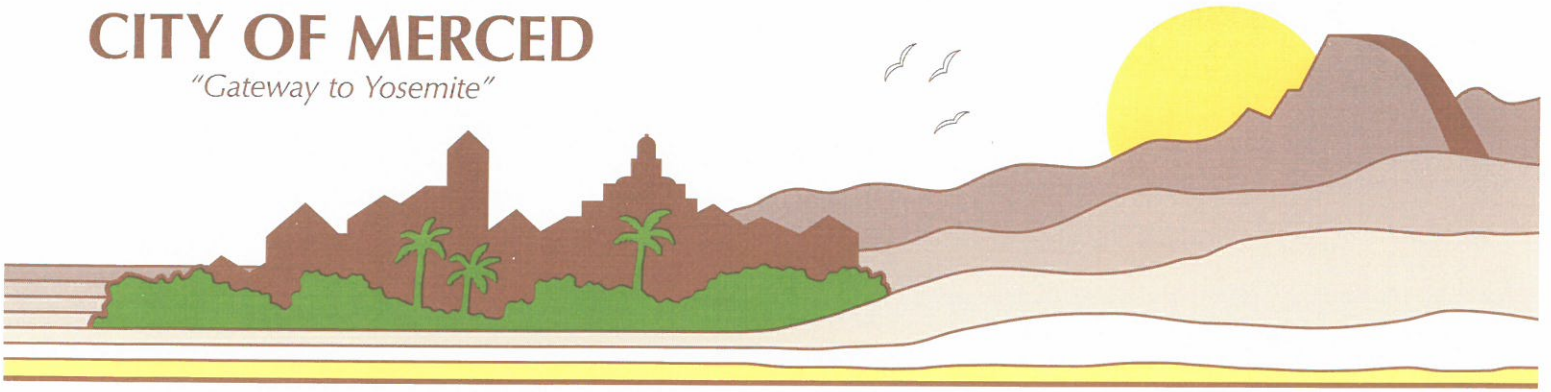

The City of Merced Housing Division is pleased to announce that it is currently accepting applications for Community Development Block Grant (CDBG), Home Investment Partnership Program (HOME), Fair Housing Services and Community Housing Development Organization (CHDO) funding requests. The City will holding informational meetings **Thursday, November 13, 2014** and **Thursday, January 8, 2015** starting at 3 PM in the Rossotti Building located in Applegate Park, near the corner of 25<sup>th</sup> and R Streets (between Kiddieland and the Zoo). A third meeting will be held on Wednesday, **December 10, 2014** at 5:30 PM in the Sam Pipes Room at Merced City Hall, 678 West 18<sup>th</sup> Street.

The 2015 HUD Annual Action Plan public meetings will be held to determine how funds are to be spent next fiscal year. The meetings will also provide information regarding CDBG and HOME funding opportunities. A final public hearing regarding the 2015 Annual Action Plan will be held before the City Council on March 16, 2015 at 7:00 PM in the Council Chambers at 678 West 18<sup>th</sup> Street.
