



MUAJ PEB TXOJ HAUV KEV TSO TEJ TEEB MEEM LOS YOG YAM TXHAWJ TXOG RAU LUB NROOG COV NOM TSWV (CITY COUNCIL) DAIM NTAWV SIB THAM

Cov Nom Tswv (City Council) thiab Lub Nroog cov Tub Ua Dej num yuav saib koj lub tswv yim muaj nuj nqis thiab yeej xav hnov koj tej kev txhawj. Nyob rau ntawd muaj peb txoj hauv kev los hais yam teeb meem los yog yam koj txhawj rau Lub Nroog cov Nom Tswv (City Council):

(1) Kej sib tham tim ncauj tim lus** (Oral Communications)

- Muab ib daim ntawv thov hais lus los sau (Request to Speak card) ua ntej cov Nom Tswv yuav sib tham.
- Muab nws rau tus Tuav Ntaub Ntawv (City Clerk) rau lub sij hawm sib tham.
- Koj yuav muaj li 3-5 feeb hais lus
- “Daim ntawv thov hais lus” (Request to Speak) muaj nyob rau thaum cov Nom Tswv sib tham thiab tseem muaj nyob rau hauv https://www.cityofmerced.org/depts/cityclerk/council_meetings/citizen_participation_instructions.asp.

(2) Sau ntawv thov thiab sib txuas lus** (Written Petitions and Communications)

- Muab ib daim ntawv los yog sau ntawv xa tuaj rau cov Nom Tswv
- Yog hais tias daim ntawv los yog tsab ntawv thov tuaj txog tsawg dua li ib as thiv ua ntej yuav sib tham, nws yuav muab tso nrog rau cov Nom Tswv daim ntawv sib tham li ib txwm muaj yuav tuaj tom ntej no.
- Nyob rau ntawd yeej tsis muaj ib daim qauv ntawv twg los yog yuav kom sau yam zoo li cas.

(3) Cov Nom Tswv hais ntxiv** (City Council Comments)

- Nug tuaj rau ib tug Nom Tswv twg.
- Nrhiav ib tug Nom tswv txiv neej/poj niam los txhawb yam khoom ntawd.
- Cov Nom Tswv muaj cov xov nyob rau ntawm tus Tub Tuav Ntaub Ntawv (City Clerk) thiab nws tseem muaj nyob rau hauv Lub Nroog qhov website (http://www.cityofmerced.org/depts/city_council/default.asp.)

Thaum muab koj cov teeb meem los yog yam txhawj txog los hais, thov hais raws li no:

- i. Muab qhov teeb meem los yog yam txhawj koj los hais.

- Yam khoom ntawd yuav tau muab los koj teem tham ntxiv thaj tsam li peb caug (30) hnuv tom qab, kom lub Nroog cov Tub Tuav Dej Num (City Staff) thiaj tshawb fawb tau nws thiab cov Nom Tswv thiaj muaj peev xwm npaj tau koj los tham.
- Qhov kev thov no ib tug ntawd lwm tus cov Nom Tswv yuav tsum tau pom zoo nrog.
