G. REPORTS

1. AIRPORT PLANNING AD HOC COMMITTEE REPORT

Airport Manager Martin Pehl briefed the Authority Members on the meeting that took place with himself and the AD HOC Committee in regards to the Airport Layout Plan.

Authority member Rafael Velarde mentioned that he would like to assist in the planning process as well as the planning report.

Authority Member Alvin Osborn stated that being that the plan is over five years old he would like to look into updating the plan.

Martin spoke in regards to what the next level of planning would be. The FAA wants a 5 year plan and Caltrans wants a 10 year plan from the airport.

2. AIRPORT MANAGER'S REPORT

Airport Manager Martin Pehl spoke about the Landing Report that the airport receives on a monthly basis. He also spoke about the total number of enplanements for the previous year.

Mr. Pehl briefed the members that the airport is at eight thousand enplanements and what the advantages that would be if the airports enplanement data would increase to ten thousand.

He shared with the members that when the airport reaches ten thousand enplanements then the grant for the airport would increase.

Authority Member Travis Colby suggested that they create another AD HOC Committee for the airport to advertise and make it possible to reach the ten thousand enplanements. He also expressed an opinion on investing a small advertisement on social media.

Mr. Pehl would like to rebuild the airport website to give the community something to go to and verify what is on the advertisements.

Authority member Rafael Velarde voiced his opinion in regards to the past due accounts and what can needs to be done to get the accounts up to date.

Mr. Colby spoke about the legal process and starting with a three day notice to pay or quit to the tenants. Mr. Colby also asked for a vacancy report and the difference in hangar rates.
